<b>In addition to fees for service of orders, the following Sheriff's Commission are collected on Sales, Tax Sales, Orders of Sale and Tax Sales.</b> <b>10 percent of the first \$10,000;</b> <b>All sums over \$10,000 but not exceeding \$15,000 is 6 percent;</b> <b>All sums over \$15,000 but not exceeding \$25,000 is 3 percent;;</b> <b>All sums over \$25,000 is 2 percent.</b> <b>When money is collected without a sale, half of the above rates shall apply.</b>
